The Campbelltown area is a great place to live and raise a family, but this lifestyle is under threat by the proposal to build a large pollution-generating Power Station less than 10km from the centre of Campbelltown.

Worst of all this Power Station is being built to supply power to Newcastle, Wollongong and other parts of Sydney.

The Power Station will have two large smoke stacks and will be fuelled by old pollution generating gas fired technology.



## HOW WILL THIS IMPACT ON YOU AND OUR ENVIRONMENT?

Macarthur already has one of the highest rates of asthma in Australia due largely to the poor air quality and high levels of air pollution in the region.

If approved by the NSW Government, the proposed Power Station will make the situation even worse, particularly for our children who suffer from asthma.

In fact, the power company has even admitted in it's own reports that more air pollution "may occur when (power) plant emissions are combined with unfavourable weather conditions".

The Power Station is also expected to lead to increased traffic and impact on the values of nearby homes.

The proposed power station uses old pollution-generating technology that will need to draw substantially from our already diminishing local water supply.

The Power Station will also produce large amounts of greenhouse gases which will have a negative effect on the environment.
